All orders must be accompanied by payment of € 3.00+ VAT as fixed charge.

Orders received after the specified deadline will be subject to a surcharge of 20% of the total due, and will be handled only after the services ordered in advance have been completed and compatibly with available personnel and means. These rates are valid only in official pre- and post- exhibition periods.

In case of cancellation of the service, the Exhibitor must promptly notify BF Servizi by sending a fax to: **+39 051 637 40 20**, or by coming to the offices of BF Servizi in the Exhibition Centre, AT LEAST 2 hours before the scheduled starting time for the rental of machinery and 24 hours in advance in case of cancellation of labour services. **Otherwise, the Exhibitor will be billed for the services.** The date and time of receipt of cancellation by BF Servizi will apply for purposes of the above.
